

On February 20th, the American Bar Association's policy-making body, the House of Delegates, changed its definition of a paralegal. The change eliminated the words "legal assistant" from the definition. The recommendation to remove the words "legal assistant or" was made by the ABA's Standing Committee on Paralegals.

See the ABA's entire revised definition below.

WHAT IS A PARALEGAL?

"A [legal assistant or] paralegal is a person, qualified by education, training or work experience who is employed or retained by a lawyer, law office, corporation, governmental agency or other entity and who performs specifically delegated substantive legal work for which a lawyer is responsible."

Your mother told you your name, not the public record.;)


