NALA Election 2018

WHY YOU SHOULD VOTE!

It takes committed voters to empower the kind of leadership that has made NALA the nation's leading paralegal association. Your vote is crucial in this process. Only Active members may vote either at the annual meeting or by proxy.

CANDIDATE QUALIFICATIONS

All candidates for NALA officer and director positions must be:

- · Legally competent to enter into contracts
- · A citizen of the United States
- · An Active member of NALA
- · Actively employed as a paralegal
- A current Certified Paralegal

ELECTION OF OFFICERS

Officers elected at the annual conference are:

- · Vice President
- Secretary
- Treasurer

These officers are elected for one-year terms, and may serve a maximum of two consecutive terms.

The President of NALA is elected for a one-year term by the Board of Directors from among its members during the third regular meeting of the NALA Board of Directors. The President-elect takes office in July with the other new officers and Board members.

ELECTION OF DIRECTORS

The directors are elected by all NALA voting members present and members represented by proxy in the same fashion as the NALA officers. Directors are elected for a term of two years and may serve a maximum of two consecutive terms.

VOTING

Only Active members in good standing forty-five (45) days prior to the annual meeting shall be qualified to vote at such meeting. Voting members present at the annual meeting, or represented by proxy, will elect officers and directors, and vote on other matters properly before the members for action.

If you cannot attend the annual meeting in July, you may designate another Active member and an alternate to represent you. The NALA Credentials/Nominations and Elections Chairperson and the NALA Secretary must receive your *Designation of Proxy* form thirty (30) days prior to the annual meeting. It is recommended to send copies of your *Designation of Proxy* form to your proxy and alternate for their information.

INSTRUCTIONS TO PROXY HOLDERS

For your convenience, NALA will prepare and post on the website an Instructions to Proxy Holder form. This form lists matters that will be voted upon. Members designating a proxy holder may use the form to instruct the proxy holder how to cast their vote.

Please do not send the Instructions to Proxy Holder form to NALA Headquarters, the NALA Credentials/ Nominations and Elections Chairperson or the NALA Secretary. This form is only for communications between members and designated proxy and alternate proxy holders.

DEADLINES

March 1

 Proposed amendments to NALA Bylaws must be submitted to the NALA Secretary in care of NALA Headquarters.

March 15

Declaration of candidacy for NALA officers and directors.

June 11

 Designation of Proxy forms due to NALA Credentials/Nominations and Elections Chairperson and NALA Secretary. Also, resolutions are due from NALA members and NALA affiliated associations for consideration during the annual membership meeting.

Directors of this corporation will be elected at the Annual Meeting in St. Louis, MO on July 11 and July 12, 2018.


In 2018, three area directors - one from each area as outlined below - will be elected for two-year terms. The area directors must reside in or be employed within any of the following geographical areas:

Annual Meeting Resolutions and Proposed Bylaw Amendments

OFFICIAL NOTICE: February 15, 2018

Business may come before the NALA membership at the Annual Meeting either through resolutions for the membership's consideration or through proposed amendments to the NALA Bylaws. With reference to the Bylaws, a member may submit a proposed amendment by delivering the proposed amendment in written form to the Secretary of the Association no later than March 1, 2018. These amendments will be considered by the Board of Directors that shall recommend for or against the adoption thereof.

Members and affiliated associations may also submit resolutions for consideration during the annual meeting. Resolutions to be considered must be filed at NALA Headquarters by June 11, 2018 and may be

proposed by individual members or affiliated associations. Resolutions are reviewed by the Board of Directors or a committee appointed by the Board. No resolution shall be offered for adoption without approval of the committee written thereon. If a question arises as to whether a resolution is within the scope and purpose of NALA, the committee shall advise its opinion. Resolutions shall not exceed 300 words.

Designation of Proxy and Alternate Proxy Form

Instructions and General Information

- 1. If you cannot attend the NALA Annual Membership Meeting on July 11, 2018, you may designate two NALA Active members to cast your proxy vote during the meeting. One NALA member will serve as your proxyholder and the second member will serve as your alternate proxyholder. The alternate is a back-up to protect your vote in the event your proxy must cancel at the last minute or leave the meeting early. Any Active member may hold your proxy with the exception of the NALA President.
- 2. Only Active members in good standing forty-five (45) days prior to the annual meeting or a special meeting shall be qualified to vote at such meeting or upon other matters coming to the members for action. An Active member who is delinquent in the payment of any dues or other assessments shall not be qualified to vote. Student, associate or sustaining members are non-voting members of the Corporation (Article III.3.9, NALA Bylaws).
- 3. Be sure your named proxyholder and alternate proxyholder plan to attend the annual meeting. If your proxyholder and/or alternate proxyholder have to leave the annual meeting before its conclusion, another member cannot hold your proxy. No proxy or alternate proxyholder may be designated after June 11, 2018.
- 4. Your Designation of Proxy and Alternate Proxy form must be sent to the NALA Secretary and the NALA Credentials/ Nominations and Elections Chairperson in order for your proxy to be recorded. The form must be **received** by these officers no later than June 11, 2018.
- 5. Remember to instruct your proxy holders how you wish your vote to be cast. Announcement of candidates and proposed bylaw amendments will be published in May/June issue of *Facts & Findings* and on the NALA Website.
