# **2020 Session Highlights**

"Passed bills are subject to review and veto by the Governor; thus, some of the bills listed as passed in this volume may be amended and some may not become law"

With this qualification in mind, here are a couple highlights from the 2020 Session, as Delegate Sam Rasoul spoke to us about in a recent RVPA Virtual Lunch and Learn.

### **Agriculture**

# HB 1552/SB 272 Tethering animals; adequate shelter and space.

Outdoor tethering no longer meets the requirement of adequate shelter during extreme weather if the animal is not safe from predators or well suited to tolerate the environment. This is a huge win for our non-human companions and those of us who get frustrated with others who do not care for their animals properly! Now we have something tangible to use to hold them accountable.

#### **Commerce and Labor**

#### HB 395/SB7 Minimum Wage.

This bill increases minimum wage from its current federally mandated level. Most of these increases are not required to go in to effect until January of 2021, but it's something to look forward to as the increases are scheduled to progress. This bill will be something to keep your eye on if it may affect you or someone you know to make sure the employer is following this new regulation. This is also a bill to keep your eye on as it is likely to be altered as time goes on.

#### **Courts/Civil Law**

#### **HB 870 Statute of Limitations; Sexual Abuse.**

"...for a cause of action accruing on or after July 1, 2020, every action for injury to a person resulting from sexual abuse shall be brought within 10 years after the cause of action accrues." This ups the Statute of Limitations regarding sexual abuse from the previous statute of two years. This is a huge win for victim's rights and those representing them. Paralegals with sexual assault cases need to be aware of this change to make sure clients are properly advised and represented.

#### **Courts/Criminal Justice**

#### HB 618/SB 179 Hate Crimes; penalty.

Adds gender, disability, gender identity, and sexual orientation to the categories of victims whose intentional selection for a hate crime results in higher criminal penalty for the offender. This bill also adds that these identifiers now qualify to bring a civil action to recover damages. However, it also eliminates the mandatory minimum terms of confinement for such hate crimes. This will affect those in practices of defense and prosecution of related crimes.

#### **Elections**

#### HB 1/SB111 Absentee voting; no excuse required.

The implementation of this bill will permit any registered voter to vote by absentee ballot in any election in which they are qualified to vote. This couldn't come at a better time for our current health situation in America, but there are plenty who oppose this form of voting for various reasons. Guess we will have to see how this works as a community and determine if it is best practice.

#### **Transportation/Motor Vehicles**

HB 874/SB160 Holding handheld personal communications devices while driving a motor vehicle.

Drivers are now prohibited from holding their cell phone while driving. Although this bill doesn't go into effect until January 1, 2021, it is helpful to know it's coming and that law enforcement will be on the look-out in the near future. The goal of this bill is safety of all those affected by motor

vehicles.

### **Weird Laws**

# Put away those x-ray glasses when buying new shoes!

In Virginia, it is a Class 3 misdemeanor to use an x-ray machine or similar device for fitting shoes.

In the 20<sup>th</sup> century, x-rays were starting to be used in medicine and most of the public was fascinated by the invention. Investors began looking for practical uses for x-ray machines in everyday life. One of the practical uses proposed was to let sellers view their customer's feet while trying on different shoes. These x-ray machines were small wooden boxes with an opening to insert a foot. The foot would then be x-rayed so that the salesperson could see where the foot ended and where the shoe began. This technology would have helped tell sellers if the shoe was a good fit.

Of course, the public did not yet know about the dangers of radiation. After research started to come out, it was discovered that x-ray radiation was linked to cancer. Virginia Code 18.2-321 was then passed in 1950, banning these x-ray machines.
